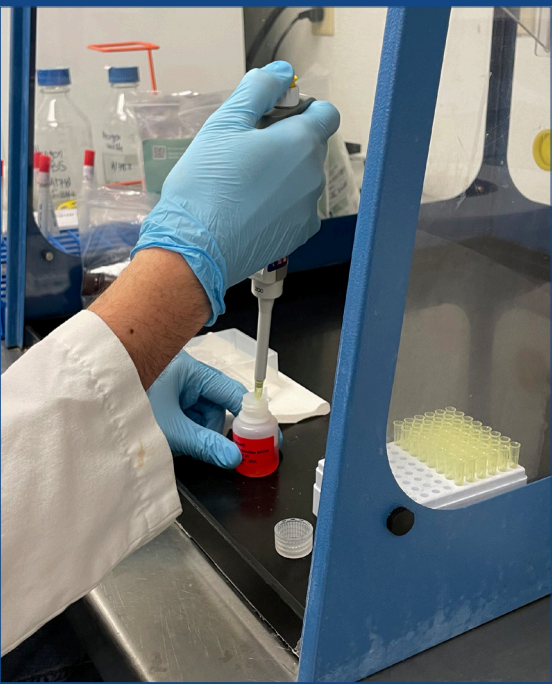

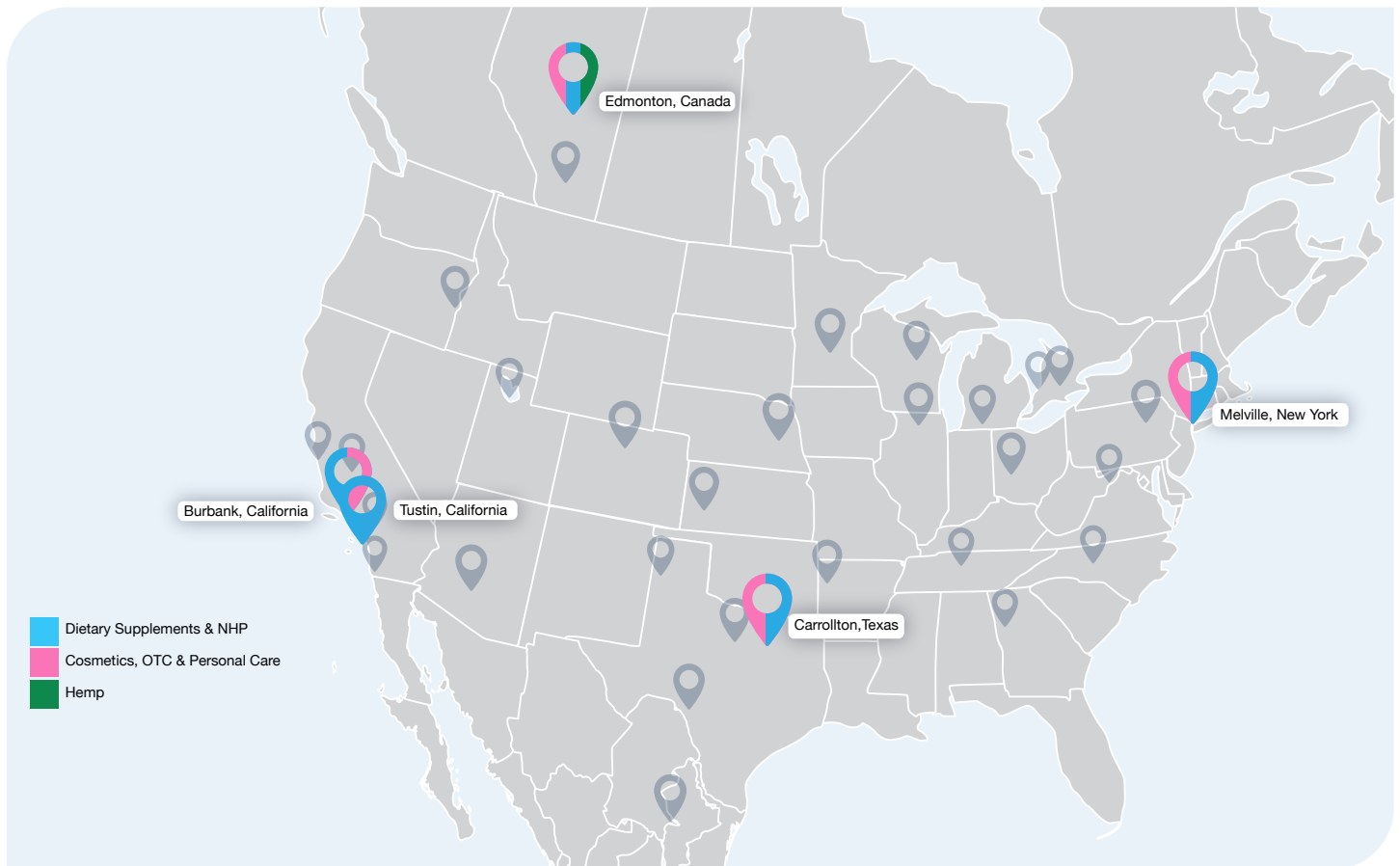

Microbiology

Our FDA Monograph testing ensures compliance with regulatory requirements, verifying product quality, efficacy, and reliability using state-of-the-art equipment and validated methods.

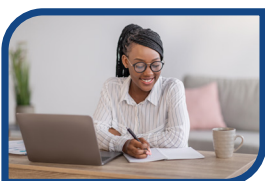
